Assessing Behaviors in Children with Deafblindness and Low Incidence Disabilities

School educational teams are responsible for evaluating the needs of students with disabilities and providing intervention strategies to address identified needs. Although each child presents unique learning characteristics, children who have a combined vision-hearing loss (deafblindness) may exhibit challenging behaviors that affect the capacity to accurately assess and identify a child's needs for purposes of designing and implementing appropriate instruction and intervention. *Assessing Behaviors in Children with Deafblindness and Low Incidence Disabilities* is designed to assist school psychologists and other educators in assessing student behavior and using those assessment data in the development of individualized behavior intervention plans.

Speaker: *Melinda Wolford, PhD, NCSP* is an experienced school psychologist and neuropsychologist. She previously served as an assistant professor in school psychology and has expertise in assessment, intervention, parent training, staff development, and consultation.

Target Audience: School psychologists, intervention specialists, parents, speech-language pathologists, other related services providers, and other agency professionals

Session 3: Sensory-driven Behavioral Intervention for Children with Deafblindness and Low Incidence Disabilities

Learning Objectives:

1. Identify function/s of sensory-driven behaviors including sensory craving, sensory seeking, or sensory resisting responses
2. Discuss the variance of sensory interpretations and sensory supports that may be utilized to reduce or replace inappropriate or harmful sensory-driven behaviors
3. Utilize evidence-based practices and strategies to build self-regulation skills and replace inappropriate sensory responses with constructive behaviors
4. Develop interventions to replace harmful self-stimulatory and self-injurious behaviors with more effective responses
