



Model Internship Program

Milestones developed a model for community-based internships for high school students with autism, based on its experience with eight students from Beachwood and Monarch Schools. With the support of The Mt. Sinai Health Care Foundation and the Meisel Family Foundation, Milestones is placing and supervising ten additional students at local businesses. The goal is to increase access to such internships across the community.




